3. I have also reviewed a Statement of Bishop Phillip Newell dated 11 November 1999 and a letter from the Bishop of Tasmania to the Venerable L V Daniels dated 28 July 1994.
4. Having reviewed these documents, they do not refresh my memory of a meeting on 10 June 1994 with Bishop Newell and Bishop Stone.
5. I have made further searches and now located my 1994 appointment dairy. My appointment diary includes an entry on 10 June 1994 of a lunch with Bishop Newell and Bishop Stone. Annexed hereto and marked "KR1" is a copy of that page of my diary.
6. The page for 10 June 1994 reads:

10am James Grant

10.45 Rehearsal ?

*12noon Phillip and Ron
LUNCH*

*2pm Hs of C (Heads of Churches)
156 Collins St (Pres)*

I have no recollection of this lunch.

I have read the account of the lunch meeting provided by Bishop Newell and Bishop Stone and I have no reason to doubt their account.

7. I have no comment on any of the documents other than the memoranda dated 30 November 1994 from Bishop Phillip Newell to Diocesan Bishops / Administrators re Resignation of a Priest (STAT.0804.001.0066). This memoranda announces the resignation by the Bishop of one of his clergy. It is most unusual for a Bishop to notify his fellow Bishops of a resignation in this way. A memorandum of this kind would have been taken by those to whom it was directed to suggest to me a serious misdemeanour which would suggest something out of the ordinary had occurred.

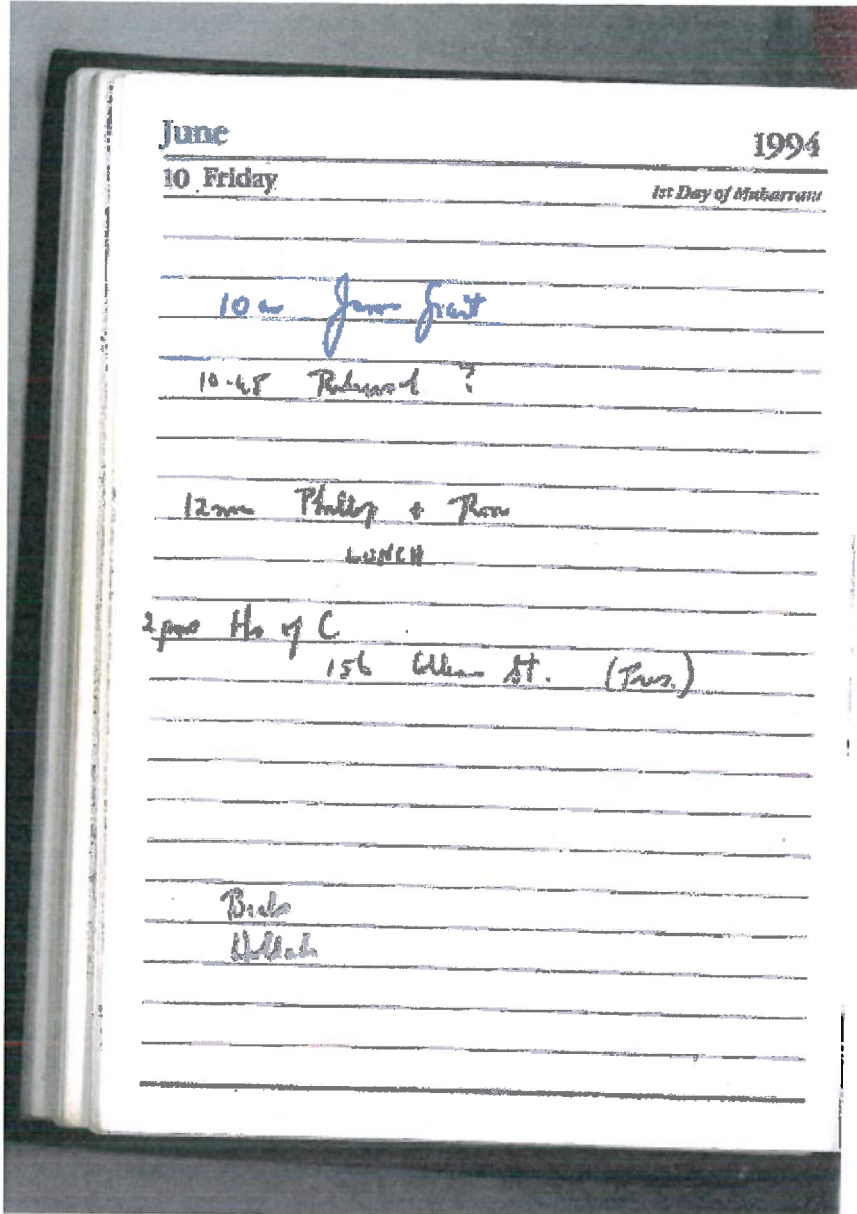
