2	<i>Indecent Dealing Child U13</i>	Yr 1999. On school camp at Rottnest. Touched complainant's leg and thigh.	
Charges relating to complainant ^{CDX} (male, aged 9 or 10 at time of offending, aged 19 at time of first trial)			
3	<i>Indecent Dealing Child U13</i>	Yr 2000. Sitting on ^{CDV} 's lap in classroom. Touched complainant's penis through pocket of shorts.	pp.334 - 376
4	<i>Indecent Dealing Child U13</i>	Yr 2000. Sitting on ^{CDV} 's lap in classroom. Touched penis through pocket of shorts.	
5	<i>Indecent Dealing Child U13</i>	Yr 2000. In classroom. ^{CDV} pulled complainant's shorts and underwear down and masturbated him.	
Charge relating to complainant ^{CGZ} (male, aged 9 or 10 at time of offending, aged 20 at time of first trial)			
6	<i>Indecent Dealing Child U13</i>	Yr 2001. At school. Touched the complainant's upper thigh whilst ostensibly measuring him.	pp.187 – 217
Charges relating to complainant ^{CHA} (male, aged 8 - 11 at time of offending, aged 12 at time of first trial)			
7	<i>Indecent Dealing Child U13</i>	Yr 2007. Following maths test. In classroom. Put hand down complainant's shorts and touched his buttocks.	pp.138 – 161

8	<i>Indecent Dealing Child U13</i>	Yr 2007. Following spelling test (same day as Ct 8.) Put hand down complainant's shorts and touched his buttocks.	
9	<i>Indecent Dealing Child U13</i>	Yr 2007. Last day of term 4. In classroom. Put hand down complainant's shorts and touched his buttocks.	
10	<i>Indecent Dealing Child U13</i>	Yr 2009. In classroom. Put hand down complainant's shorts and touched his buttocks while complainant was reading to him.	
Charges relating to complainant ^{CHB} (male, aged 9 at time of offending, aged 11 at time of first trial)			
11	<i>Indecent Dealing Child U13</i>	Yr 2008. In classroom during term 2, looking at some maths questions. Put hand down complainant's shorts and touched his buttocks.	
12	<i>Indecent Dealing Child U13</i>	Yr 2008. During term 2. In the classroom correcting a spelling mistake. Put hand down complainant's shorts and touched his buttocks.	
13	<i>Indecent Dealing Child U13</i>	Yr 2008. During term 3. In the classroom after ^{CHB} had been moving his desk. Put hand down complainant's shorts and touched his buttocks.	pp.161 – 186
14	<i>Indecent Dealing Child U13</i>	Yr 2008. In term 4. Outside the music room. Rubbed complainant's buttocks on the outside of his shorts.	
15	<i>Indecent Dealing Child U13</i>	Yr 2008. Last day of term 4. In the classroom. Rubbed the complainant's buttocks on the outside of his shorts.	
16	<i>Indecent Recording Child U13</i>	Yr 2008. Took a photograph of the complainant in the school grounds.	
17	<i>Indecent Recording U13</i>	Yr 2008. Took a photograph of the complainant in the school grounds.
