6. About 8:40am on Thursday 25 August 2011, I received an email from Constable Amanda JOHNSTON, requesting written confirmation of the airing times and occasions of the movie "Charlie and The Chocolate Factory" for WIN Canberra.

About 10:40am on Thursday 25 August 2011, I replied to Constable Amanda JOHNSTON's email request, advising that the movie, "Charlie and The Chocolate Factory" had been telecast during the 2011 period on two occasions; On Saturday 12 March 2011 between 7:30pm and 10:00pm; and, On Saturday 13 August 2011 between 7:30pm and 10:00pm.
 8. On both these occasions the program, "Australia's Funniest Home Videos" was telecast before the movie, "Charlie and The Chocolate Factory", between 6:30pm and 7:30pm.
 9. About 4:00pm on Monday 29 August 2011, I received an email from Constable Amanda JOHNSTON who asked me if I would provide her with a statement in relation to this matter, and attached a drafted statement to my email, requesting that I check the accuracy of the detail contained therein.
