Hi all

The above matter was in Court yesterday and the answer charge date of **21 June 2011** was confirmed. I intend to put together a memo by the end of this week with a recommendation as to the charges and I will hopefully have instructions about that by the end of next week.

What I intend to do is come down to Christies for a day and meet with all of the parents. We did this last time for the proofings and it worked quite well. I would prefer to have Fabiana with me if we can find a day when we are both free in the week of the 14th of June. Dean or Steve, once you hear from Penny about a suitable date for DPP, can you please arrange 7 x 45 minute blocks - with one block for each set of parents. I would recommend:

10 - 10.45
 10.45 - 11.30
 11.30 - 12.15
 12.15 - 1

2 - 2.45
 2.45 - 3.30
 3.30 - 4.15

The children do not need to come to this meeting, it will be for me to explain to the parents what is happening with the charges. You can tell them that at this stage no decision has yet been made but I will be able to explain whatever decision is made on the date we set down.

Penny, can you please find a date asap in the week of the 14th and let Dean and Steve know. Preferably avoiding the Friday but if it has to be that date I will find someone to do my subs.

The following matters still need to be attended to (I have re-prioritised, with the items in bold now being most important):

1. Addendum from ALBON addressing the disclosures made by the children during proofing - I need this by 7 June 2011 (don't worry about sending through SCADS, just leave in the DPP tray for collection on 7 June)

2. Statements from police including:

- **MILLMAN** - can I please have this by **7 June 2011** (don't worry about sending through SCADS, just leave in the DPP tray for collection on 7 June)

- All police officers who searched the Defendant's home and who can corroborate the arrest:

Has the computer equipment and cameras seized from the accused been submitted to E-Crime for analysis, if so, please submit as a matter of urgency and advise me of the estimated completion date

There is reference to a crime scene examiner attending to examine the bus, did this happen?

3. Does the accused have a next door neighbour/associate by the name of [REDACTED]? The children mention him being present on the bus and taking photographs of [CDF] hurting them. This needs to be investigated as a matter of urgency. **Dec from PERRY about the door knock and subsequent enquiries - I need this by 7 June 2011** (don't worry about sending through SCADS, just leave in the DPP tray for collection on 7 June)

4. **Verified transcription of the record of interview with the accused**

5. **Statement from the Dr who saw [CEK] after his parents discovered him putting cotton buds in his bottom**

6. Statement from [CEU] ([CET] s mother)

7. **Proof of the accused's employment at SERU and the dates for which he was driving the bus to [REDACTED]**

8. Do we know the park that the children are describing, where the bus would stop? If so, photographs of that area

9. Statement from doctor who examined [CDI] at CPS

10. Signed copy of the statement obtained from [REDACTED] by PERRY
