I am not sure what forms you are talking about. The instructions to me were for you to send the account to Air Force through SQLNDR(AAFC) Banfield however both he and I have been directed by Air Commodore Green of Cadet Branch-Air Force that we are no longer to communicate with you or CJE because of the complaint that was made that we bullied you both. That took me quite by surprise.

The Air Commodore has appointed Squadron Leader Jackie Hatch of his office to take over all contact. I know she is attempting to contact you.

You should forward the account to Squadron Leader Hatch and she will arrange payment of accounts for you. Unfortunately I do not have her contact details. I understand that Pilot Officer (AAFC) CJE has been in communication with her and she has her number.
