G'day Sir,

For your SA, you may recall a HIB in Aug 14 reference a 1 Wing (FNQ) AAFC Instructor of Cadets (IOC), REDACTED having charges laid against him for sexual interference with a minor.

Mr REDACTED's *Working with Children Blue Card* was suspended and he was placed on the AAFC Unallotted List WEF 01 Jul 14 and was terminated from the AAFC WEF 01 Jul 15 - he was last posted to 104SQN (Cairns) after transferring from 106SQN (Mareeba). The alleged incidents are believed to have occurred whilst Mr REDACTED was an instructor at 106SQN (Mareeba).

Update: Recently, Mr REDACTED has been called before the courts to answer 12+ charges of indecent dealing, rape & attempted rape of a minor. These alleged incidents appear unrelated to Mr REDACTED's past AAFC service and it is understood the minor is allegedly his daughter - not an AAFC Cadet.

I am in receipt of advice from OC 1WG via text message today concerning an ex member of the AAFC who's trial is about to commence. The ex member is Mr [REDACTED] [REDACTED] and he was last posted 104SQN after transferring to Cairns from 106SQN Mareeba.

Mr [REDACTED] has been called before the courts to answer to 12+ charges of indecent dealing, rape & attempted rape of a minor.

OC 1WG received the advice this morning also via text message after one of his staff members ([REDACTED]) recused himself from Jury service after advising the judge he knew and used to work with the defendant.

I have attached a copy of the HIB that was raised at the time along with supporting

documentation and correspondence between 1WG AAFC and the Commissioner which I instructed be retained on the members personal file at the time.

This advise is being forwarded to you and DCDR in case of potential fallout and/or media exposure as a result of his previous membership to our organisation.
