Dear CJO

Thank you for your email.

I am extremely sorry to hear about the loss of your family members over the past few weeks. The death of [REDACTED] has been felt very hard by many of the cadets like CJE who knew him well. I can only begin to understand how distressing these recent months have been for CJE.

Chirrs Adams is no longer a member of the AAFC or has any involvement with the AAFC. Air Force and the AAFC regard the alleged behaviour by Adams as unacceptable. The Air Force and AAFC are fully supporting the police investigations and we have written formally to the police asking that they take action.

The action by the NSW Police takes precedence. Action by the NSW Police will then inform possible action by Air Force.

We have provided all possible support for CJE and will continue to provide support for you, CJE and her father. I am aware that appropriate support is also being provided to any other cadets who made complaints against Adams.

We are keeping in regular contact with Detective Fletcher and we will continue to support him in any way we can.

Just touching base with you and letting you know I am keeping a Brief with the NSW Police on the progress of LAC ADAMS and the victims.

It appears that more victims have come forward to the Police and this is quite distressing. I am formerly writing to the Chief of Defence, as I need to express my deepest disgust on how this person has been able to swoon his way to many innocent victims, under the guise of a Defence Person.

It sickens me to the emph degree how a person in 'trust' has got away with it, and who knows how many more are out there that haven't come forward – because they probably feel gutted and embarrassed but are unaware of the breach of innocence he has broken.

I have been continuing to see my Psychologist, as I am unable to come to terms with the amount of hate and contempt for this person and the AAFC/RAAF.

As I have said before the letter sent regarding my husband not being able to attend more counselling sessions is just not accepted. Because of this letter, his hatred for ADAMS has boiled even more, and I can not believe how Defence took that view as they did.

I have attached an email below from the Investigating Officer from Wagga Wagga, and to say the least, Brent has been really helpful, and has advised me of further complaints made by under 18 victims by this creep ADAMS.

From my discussions with Brent Fletcher, I believe Defence needs to add to its investigations list '2<sup>nd</sup> employment' Policy with personnel. It appears that LAC ADAMS has been providing private maths tuition to girls in their homes (Maitland) and taking advantage of them – makes my skin crawl!!

I also want you and Defence to know, I just hope and pray that CJE did 'ok' with her exams. He has been so stressed to say the least! This issue not being resolved hasn't helped, and to add to her woes our family lost two brother-in-laws with in weeks of each other and one of CJE's best friends REDA only aged 17 yrs, a former AAFC from the northern beaches, committed suicide. CJE and the kids in their group were very very distraught from this. CJE attended two funerals in one day in between exams – a very distressing time for her.

Can you advise what strategies Defence is taking in respect to ADAMS, and the number of Policies for both AAFC and Defence that need a review? Following these complaints.

We are now in November the complaint was raised in May (for CJE ).

You just don't know what stress this is causing the family.

Whilst I was away I received a transcript of the interview I conducted with ADAMS as well as some other info that I requested in relation to his telephone.  
Due to the volumous quantity of these documents, I haven't had the opportunity as yet to analyse them - next week.

I also have to contact the officer at Maitland who is investigating further complaints against ADAMS to see if he has obtained any info which may assist CJE [REDACTED]'s matter - I will do this on Monday.

If there is nothing significant gained from this, I will submit the brief for a legal advising.

Unfortunately I can't give a time frame as to when this advising will be completed, however my priority at this stage is making sure that a quality brief is presented so that the right decision can be made.

I will contact you by the end of next week to provide a further update and confirmation of what is occurring.
