Licence Function

This organisation is granted a licence to:

- recruit, train, assess and support departmentally approved carers, and provide additional support for the placement through the employment of direct care staff.

A licensed care service must comply with the relevant provisions of the *Child Protection Act 1999* and the *Working with Children (Risk Management and Screening) Act 2000*, and the conditions listed on this licence.

Licence Conditions

1. Persons defined under s126(b) of the *Child Protection Act 1999* and Chapter 8, Part 6, Division 1 and Schedule 1, Part 1 and 2 of the *Working with Children (Risk Management and Screening) Act 2000* must be suitable persons, and comply with Blue Card requirements.
2. The service must have a process for ensuring that Blue Card applicants do not pose a risk to children and young people in the service prior to receiving their Blue Card.
3. The Nominee must, under s137 of the *Child Protection Act 1999*, apply to amend the licence using the *Licensing of Care services (LCS) Form-4A* where changes to the licence are necessary or desirable.
4. The Nominee must, using the *Licensing of Care Services (LCS) Form-4B*, notify the Department of Communities, Child Safety and Disability Services (DCCSDS) of any other changes affecting the basis upon which the care service licence was originally granted.
5. The Nominee must, using the *Licensing of Care Services (LCS) Form-6*, notify DCCSDS of any changes to domestic violence and traffic infringement histories of all persons engaged by the service in regulated employment, whether the employment is paid or voluntary.
6. The licensed care service must comply with, and maintain, the relevant DCCSDS quality assurance system for licensed care services.
7. The licensed care service must collect and provide to DCCSDS data of the type and format requested by the department pursuant to s9 of the *Child Protection Regulation 2011*.
8. This licence has been granted on the basis that the Licensee meets the requirements for s126 of the *Child Protection Act 1999*. The Licensee must ensure that the care service continues to meet these requirements for the duration of the licence.
