Dear Attorney General

You may recall our 9 October 2015 letter regarding the Royal Commission into Institutional Responses to Child Sexual Abuse. We thank your Office, particularly Dr Susan Cochrane, for the follow up discussions where we were able to outline the position of Scouts Australia in greater detail in relation to many of the Royal Commission's recommendations.

In welcoming the Royal Commission's report, we stated our belief that a national redress scheme was imperative for survivors of child sexual assault. Recognising the higher cost for small not-for-profit community organisations, and the likely inequities for survivors, we also believed the Commonwealth Government has a critical role to play in establishing a single national framework for managing claims.

Scouts Australia is therefore pleased to learn that the Commonwealth Government will lead the development of a national approach to redress (29 January 2016 Joint media release). We are also pleased the Federal Government recognises the importance of developing a national approach to redress as quickly as possible, and that discussions will commence shortly with State and Territories to work through the many complex issues. We also support the proposal that all governments commit to core principles and processes for the assessment and payment of redress.

As previously stated, Scouts Australia will accept its responsibilities, and obligations, towards those who have been harmed in our care. We recognise that application of any retrospective liability as part of a redress scheme will create far-reaching implications for our organisation. Some of our Branches will be challenged in their capacity to continue delivering a contemporary, non-formal education based youth development program for Australian families.

Scouts Australia is ready to assist the Commonwealth Government, and State and Territory Governments, in any way practical with the development of a single national redress scheme. In this context, we would be grateful for the opportunity to assist with the development of, or to comment on, the draft set of national principles for the assessment and payment of redress.


