Generally it is very good but there are a few things that seem out of sequence, that need editing:

There is a discontinuity in the introduction of 'Real Justice' on page 2:

The line:

In framing these services, the Ashram has used the services of external experts who have extensive experience in addressing similar issues in the Roman Catholic Church.

Might be better as:

In framing these services, the Ashram has used the services of external experts, from a group called 'Real Justice', who have extensive experience in addressing similar issues in the Roman Catholic Church.

-since this group is discussed immediately after - with no introduction.

The same problem happens with introducing Terry: he is talked about before defining who he is and what organisation he relates to.

It will be interesting to see reactions to this given the previous rejection of any ideas of counselling.
