As present communications have slowed down with the victims. At present there are 3 people working with Terry. [REDACTED] Bhakti Manning and [APH] Honestly I'm not sure either way if it is appropriate to give Swamiji the names or not.

Terry send updates to Surya. I was in contact with him also recently and he has set them 'homework' so the process is moving slowly but seemingly steadily.

The Survivor Package has not been sent to Swami Nirajan as far as I know. (attached)

No further communication with the victims since [APH] sent her application. Alecia, her mum, [APL] and [JYOTI] have been in contact directly or indirectly with questions about Terry and Real Justice. So far they have not submitted an application but i believe they are waiting to see how it pans out for those currently

engaged with him.

Bert suggested a letter of understanding be drafted for Munger in regards to **REDACTED** living there. (Not a good look in regards to the catholic churches habit of shuffling sex offenders to other parishes or countries) The letter would be a protection for SYA should someone raise the issue and also would be a starting point for communications with Munger regarding this kind of practice and to develop guidelines and agreements around this that don't leave SYA and the SY name vulnerable to disrepute.
