LAST YEAR SIMON, PUBLICLY DESCRIBED A CHILDHOOD OF SEXUAL ABUSE BY ANGLICAN PRIESTS IN TASMANIA.

TWO MONTHS AFTER HE WENT PUBLIC THE CHURCH LAUNCHED AN INQUIRY ... WHICH THIS WEEK REVEALED HE MAY BE JUST ONE OF NUMEROUS VICTIMS

ONE PRIEST TOLD THE INQUIRY OF AN
ORGANISED CHILD SEX RING ... THE MAN
SAYING HE'D TRIED TO LEAVE:

"A HARD CORE GROUP OF CLERGY WITH
SEXUAL TENDENCIES TOWARD YOUNG MALES",

WHICH HE "DESCRIBED AS THAT "GRUBBY
LITTLE CIRCLE".

BLUE 398 KOHL 19:30 THERE WERE A NUMBER
OF PEOPLE WHO WERE OBVIOUSLY FRIENDS
WITH ONE ANOTHER AND THAT IS HOW IS WAS
REFERRED TO : AS THAT GRUBBY LITTLE
CLIQUE. A NUMBER OF THEM ARE NOW DEAD
AND NONE OF THEM ARE PRACTISING IN
TASMANIA.

AND THE "SEXUAL ABUSE OF CHILDREN AT

BLUE 398 KOHL 18:55 PROBABLY THE RAPES
GOT THROUGH TO MY PSYCHE MORE THAN
ANYTHING ELSE AND IN PARTICULAR ONE
RAPE BECAUSE THE PERSON WAS A CHILD AND
THEY FELT TOTALLY UNABLE TO TELL ANYONE
WHAT HAD HAPPEN AND THAT PERSON ONLY
DISCLOSED THAT LAST YEAR WHEN THEY
FIRST SPOKE TO US AND I THINK I FOUND
THAT HORRIFIC THAT A CHILD COULD SUFFER
AND NOT BE ABLE TO DISCLOSE.

LAST YEAR, A MINISTER CAME FORWARD
CLAIMING HE'S BEEN AWARE OF
PAEDOPHILLIA WITHIN THE ANGLICAN CHURCH
FOR THIRTY YEARS.

NOW, THE INQUIRY HAS CRITICISED THE
CHURCH'S REPOSE TO PAST COMPLAINTS.

IT DESCRIBES A PERCEPTION AMONG ALLEGED
VICTIMS WHO'D MADE ALLEGATIONS THAT:

"BISHOP NEWELL HAD TAKEN NO ACTION AND
IGNORED THEIR CONCERNS"

IT ALSO NOTED:

"A SELECTIVE AND CONVENIENT MEMORY
AMONG SENIOR CHURCH MEMBERS"

QUESTION HYLAND 1:48 SHOULDN'T THESE VICTIMS HAVE BEEN ENCOURAGED TO GO TO THE POLICE?

BLUE 94 KOHL 2:55 THE CHILD SEXUAL ABUSE I PERSONALLY THINK THAT SHOULD HAVE GONE TO THE POLICE AT EARLIER STAGES BUT AT THE TIME THE PEOPLE WHO WER ASKING FOR THE COMPLAINT NOT TO GO ANYWHERE WERE THOSE CHILDRENS PARENTS AND THAT THEN A DIFFICULT LINE OF WHETHER YOU ACCEPT WHAT THOSE PARENTS WANT YOU TO DO OR WHETHER YOU TAKE A STAND AND WE'VE RECOMMENDED IN THE REPORT THAT IF CHILD SEXUAL ABUSE IS REPORTED THAT THE CHURCH MUST REPORT IT REGARDLESS OF WHAT THOSE CHILDREN'S PARENTS WANT.

BLUE 807 SIMON 3:02 THE CHURCH'S RESPONSE TO ALLEGATIONS WHICH WERE CLEARLY CRIMINAL ALLEGATIONS SHOULD HAVE BEEN TURNING THEM OVER TO THE POLICE WHICH IS IN LINE WITH THE LEGAL PROCESS.

BLUE 60 PRINS 1:03 THE THING THAT I SAY NOW TO ANYBODY WHO DID GO TO THE INQUIRY COME TO US AND LET US TAKE A STATEMENT AND INVESTIGATE A MATTER AND THEN WE CAN TAKE IT FROM THERE.

THE CHURCH SAYS IT WILL ADOPT NEARLY ALL OF THE REPORT'S RECOMMENDATIONS .. INCLUDING SETTING UP A REGISTER OF SUSPECTED OFFENDERS.

BUT THE CHURCH MUST STILL DEAL WITH COMMUNITY ANGER OR RESENTMENT THAT PLEAS FOR HELP WERE SEEMINGLY IGNORED. BISHOP NEWELL PLANS TO MAKE THE UNPRECEDENTED MOVE OF AN OFFICIAL APOLOGY ... THE QUESTION IS, WILL THAT BE ENOUGH.

BLUE 807 SIMON 7:20 IF NEED BE THE BISHOP SHOULD GO. I BELIEVE THAT THE BISHOPS OWN ADMISSIONS ON THIS SUBJECT POINT TOWARDS THAT FACT AND I BELIEVE IT'S APPROPRIATE THAT HE PROBABLY RESIGN AND THAT SOMEBODY WHO'S MORE AWARE OF THESE PRESSING SOCIAL ISSUES TAKE HIS PLACE.

BLUE 94 KOHL 5:00 IF HIS HEAD WERE TO ROLL FOR YHE FACT THAT EH HAS MADE SOME ERRORS OF JUDGEMENT THEN WE MADE END UP WITH A MORE CONSERVATIVE PERSON IN PLACE THAT WON'T IMPLEMENT ANY OF THE RECOMMENDATIONS.
