Again if there is any problem in accessing this information please let me know at your earliest convenience.

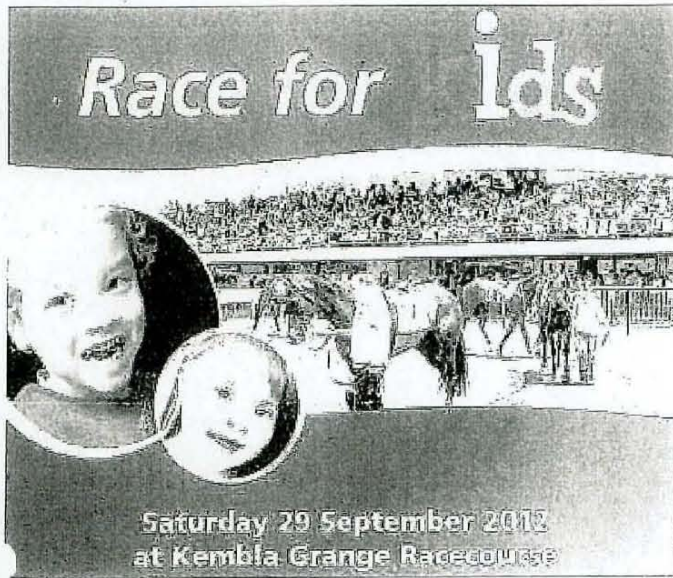
