Hi Margaret

In regard to the letter received from Slater & Gordon dated 30th October I have discussed the requirements with Workplace Law and suggest you respond as follows:

 Ok to provide details of awards/agreements
 Ok to provide Job Description

We suggest the following response in respect to Item 4:

"In regard to Item 4 we are not able to prove this information and it would be more appropriate for you to contact the relevant government authority. We are not sure as to why you require this information as the investigate has been finalised and the matter closed.

In relation to your comments regarding your client's return to work we refer to your own letter of the 30th October and advise that the position has not changed since our email to Mr Comber dated 18th July 2012"

Margaret as I do not have a copy of the mentioned email would you check to make sure it is the one that advised Comber that there were no jobs currently available to meet his stated requirements.

Based on what we have been able to find out the same letter has been sent to Interchange and Focus.
