> Thanks for this. I have made arrangements to fly up first thing on
 > Monday and stay until end of Tuesday to begin the investigation. I
 > will stay at Rydges Hotel (unless you can get a better deal anywhere
 > else).

> I have booked a meeting room for both days at the firm with whom we
 > have an alliance. It is Marshall Marks Kennedy and their offices are

> The list looks fine. We need to add to it members of the State Squad
 > at the time she was in the squad (1997/8) and people who may have been
 > at the December 1997 camp, if you know of any. I have attached a
 > contact sheet to be completed with all the details. It is in excel
 > format. It would be good to get this filled in asap.

> I have also emailed S Healy and advised him of our plans and get him

 > We should make the arrangements in the next two days so people are

> what they are about) about NC which TNSW is investigating and we would
 > be pleased if you could come and attend a meeting as part of that
 > investigation.

 > interest to get the matter resolved and we can't do so if we don't
 > have information. If they can't come on Monday or Tuesday then ask if
 > they are happy for me to call them and/or make another time which
 > suits. I am happy to talk to anyone who wants "more information"
 > before they attend.

 > end.
