The response is impertinent and self-serving. It displays no real regard for the Salvation Army and those whom they are trying to protect. It is my view that he remains a high risk, notwithstanding his re-acceptance, which I believe was on false grounds. I have yet seen any admission of guilt of his actions which is a key feature of acceptance and a willingness to change ones ways for the better.

I have about 8 interviews before I get to the interview stage with Mr HAGGAR (about 2 weeks) and feel that especially whilst 'we are under the spotlight' as he puts it, that she must be applying proper risk management strategies. The behaviour he is displaying alone gives rise for additional concerns.

Unbelievable.

There was no need for this to escalate to this degree if he had been willing to work with PSO.

This response is bullying.

Where is the contrition for his past offending and for working with restorative ways that indicate he understands the long term consequences of his actions?

I've now read the letter to [REDACTED] so I recommend a similar standard of risk mitigation from the Chief to Haggar.

So much for his quoted abiding by his Officer's Covenant from his email of 27/1/2014! He also broke it in 1989.

Key messages to him should be:

- a person who is the subject of a serious child sexual abuse investigation does not dictate his written agreement to the organisation that he was representing at the time of the offence.
- 
- the WA that was prepared would not have greatly impacted his current attendance at SCH but his refusal to enter into it leaves TSA with no other option now but to exclude him from attending any corps
- 
- His pastoral care can be outside of a corps context through his corps officers.
- 
- the TC has no other choice but to suspend his officership status as a retired officer in accordance with the O & Rs for officers

It is imperative that the TC acts quickly and consistently on this matter as I see from Haggar's response that he is becoming more and more defiant at pushing the organisational boundaries.
