UNDERTAKINGS ENTERED INTO BY AN OFFICER


1. I accept and will faithfully teach the doctrines of The Salvation Army.

4. I will totally abstain from the use of intoxicating drink, tobacco, pernicious drugs, and any other practice inconsistent with Salvation Army standards.
5. I will accept the direction of my leaders in regard to my appointments, trusting that God will guide them in sending me where I can most effectually advance the Kingdom of Christ. I will faithfully fulfil all the requirements thereof; and will not engage in other remunerative employment.
6. I give myself of my own free will to the work of The Salvation Army, and understand that there is no contract of service, and that accordingly I will have no legal claims upon the Army. I understand and agree that, although I may expect to receive an allowance according to an official scale, no allowance is guaranteed to me.
7. I will be responsible for my own personal expenses (and those of my dependants), including medical and educational costs, unless provided by The Salvation Army.
8. I will not solicit or knowingly encourage any presentation of any gift or testimonial to myself, or use my position as a Salvation Army officer for personal gain.
9. I undertake to keep all required records of my work and so account for all monies entrusted to me.
10. I will seek to express any creative ability I may have in ways such as writing, song and music composition in order to further the aims and principles of The Salvation Army, and in seeking publication will follow the procedure laid down in orders and regulations.
