1. The problem FT said he was in a Salvation Army Children's Home during the 1970's in Goulburn. He says he was sexually abused during this time by a Salvation Army officer Captain Graham Laurie-Wilson. He said the matter is being dealt with legally and by the D.P.P., but he wants to seek his own justice. He wants the address and phone number of this officer. He said he will then go and be violent (bash, kick etc) this person, his wife and 2 children. He said the rest of the family are the same as Capt.
