*** CASE PROGRESS NARRATIVE ***

ADDITIONAL INFORMATION:

IN 1967-68 WHEN THE COMPLAINANT WAS APPROX 11-12 YRS OLD HE WAS SEXUALLY ASSAULTED ON THREE OCCASIONS BY FATHER DESMOND GANNON 27/8/1929 MNI 961999537 (PRIORS FOR SEXUAL ASSAULTS ON BOYS) ON THE FIRST OCCASION COMPLAINANT WAS TAKEN FROM STPATRICKS PRIMARY SCHOOL IN KILMORE BY FR DESMOND GANNON ON THE PRETEXT OF COLLECTING SOMETHING FOR THE SCHOOL. HE WAS THE ONLY STUDENT TO BE ASKED TO ASSIST FR GANNON AT THAT TIME. THE COMPLAINANT WAS TAKEN TO AN AREA IN KILMORE WHERE FR GANNON REMOVED ALL HIS CLOTHING. GANNON THEN PATIALLY PENETRATED THE COMPLAINANTS ANUS WITH HIS PENIS. WHEN FULL PENETRATION COULD NOT BE ACHIEVED HE THEN REMOVED HIS PENIS AND PLACED IT BETWEEN THE LEGS OF THE CHILD. HE MASTURBATED HIMSELF IN A THRUSTING MOTION IN THIS FASHION BUT IT IS NOW KNOWN IF HE EJACULATED. ON THE SECOND OCCASION THE COMPLAINANT WHILST ALSO A STUDENT AT ST PATRICKS PRIMARY SCHOOL IN KILMORE ATTENDED CHURCH TO ACT AS AN ALTAR BAY. PRIOR TO MASS GANNON TONGUE KISSED THE COMPLAINANT WHILE AT THE SAME TIME PUT HIS HAND DOWN INTO THE COMPLAINANTS PANTS AND FONDLED HIS PENIS.

ON THE THIRD OCCASION THE COMPLAINANT WAS SWIMMING AT ASSUMPTION COLLEGE IN KILMORE WHEN GANNON ASKED HIM TO GO TO A PUMP ROOM NER THE POOL. THERE FATHER GANNON TONGUE KISSED THE COMPLAINANT AND ALSO PUT HIS HAND DOWN INTO THE COMPLAINANTS PANTS AND FONDLED HIS PENIS. STATEMENT OF COMPLAINT OBTAINED FROM BTQ [REDACTED] STATEMENT OF AGE AND PARTICULARISATION OBTAINED FROM [REDACTED] SHEPPARTON SOCAU CASE BK.NO.226/07.REFERS.
