Information:	<p>Information: On 7/3/2001 I was contacted by REDACTED of REDACTED Mill Park (H) Ph: REDACTED (M) REDACTED. He stated that he was a victim of sexual assaults in 1977. The offender was named as Father Michael ▶ ◀ GLENNON who is currently in custody as a result of previous convictions for offences against children. REDACTED stated that he was willing to make a statement in rrelation to the incidents. The first incident occurred in Murray Bridge, South Australia and the second incident occurred at lancefield, Victoria at a youth camp/football trip. The assaults onsisted of GLENNON rubbing his penis against the victim whilst naked in bed, the second incident involved fondling of genitals and masturbation. The victim was advised that GLENNON was in custody for numerous previous offences and that I was unsure if the O.P.P would prosecute again.
