Dear Mr. Jackson,

I forward you herewith a copy of a report made by Mr. E.G. Marriott, my Institution Officer, on the conditions prevailing at St. Joseph's Farm School, Binsloo.

I may say that I am in full accord with the report submitted to me by Mr. Marriott. The conditions at Binsloo are not good. As a matter of fact, the educational facilities provided for the boys are most inadequate and I fail to see how they can receive proper schooling. Furthermore, the conditions generally do in no way conform to those at other institutions, or for that matter the provisions of the Child Welfare Act.
