3. METHOD OF OPERATION: The offender is a Captain in the Salvation Army and occupies premises at REDACTED Rivervale where he also conducts a youth club each Friday night. On evening of 14.12.73 offender took several of the boys home after the club had finished and one of those was the complainant. After the other boys were dropped off the offender drove the complainant to an area near the Belmont Racecourse where he touched the boy on his private parts and he then pulled out his own penis and wanted the boy to play with it. The boy refused and offender grabbed his hand and placed it on his penis, and masturbated until he ejaculated.

2. Between 1.2.73 and 28.2.73 offender took members of youth club to picnic at Crawley. He later took complainant and another lad back to his address at Rivervale. On arrival the offender took the complainant to his bedroom where he fondled the boys private parts. The offender then took his penis out and wanted complainant to masturbate him but the boy refused. The offender took hold of complainant's hand and held it on his penis until he had masturbated himself.
