I am 35 years old, born on the REDACTED, 1959 in Perth, Western Australia.

My parents are REDACTED and REDACTED REDACTED

When I was eight years old, mum and dad separated.

Between the ages of 11 and 13 I was sexually abused by Charles Alan SMITH.

In January of 1971 my family which consisted of my mother, two sisters and one brother moved to REDACTED RED, Bentley.

My mother is involved with many charities. One of which is the Salvation Army.

It was through the Salvation Army that we met Charles Alan SMITH.

He at the time was a Captain in the Salvation Army.

I would call him either Captain, or Smithy.

My mother would assist him collecting, She would help him go to different locations, normally hotels and collect money.

I can remember the first time something happened.

It was in 1971.

I'm unsure of the reason why I was in Smithy's car, but he was like a father figure to me so it was not unusual for me to accompany him.

My mother encouraged me to spend time with him.

We were in his vehicle, a HD Holden station wagon, it was a blue/grey in colour.

It was during the day.

Only me and Smithy were in the car, I'm not sure where the car was parked, however it was in the Perth metro area.

We were both sitting in the front seat, he had a bench seat.

He pulled his penis out of his pants.

He said, "Put your hand on it."

I said, "Why?"

He said, "Do as you're told."

He grabbed my hand and put it on his penis.

He kept his hand on top of mine and moved his hand, so my hand was moving along his penis.

I was masturbating him.

Smithy had a hankie, he had it under his seat.

He grabbed it and ejaculated into it.

I never wanted to do this, Smithy appeared very aggressive, I can remember feeling very frightened of him.

I can remember that he told me that if I told anyone what had happened I would have to go back to the 'home' and that I would never see my mother again.

It would be at least once a week that I would see Smithy, and on most occasions he would make me do this to him.

Still when I was 11 years old, Smithy would force me to perform oral sex on him.

My mother had gone into the Kewdale Hotel and was collecting money.

Smithy and myself were in the car-park, a long distance away from the hotel, under some trees.

It was easy to see when my mother came out of the hotel.

Smithy and I were both sitting in the front seat.

} Smithy took his penis out of his pants, he then masturbated himself.

He said, "Put your mouth on this." 23.

I said, "No, I don't want too."

Smithy then grabbed my head, he pushed my head over his penis, and forced his penis into my mouth.

He moved my head up and down.

I went to pull away.

He said, "Stay there." He sounded angry.

Smithy continued to do this until he ejaculated into my mouth.

Smithy gave me a drink afterwards.

Smithy made me do this to him on many occasions.

It would happen often at the Kewdale Hotel, or many other hotel car-parks in the metro area.

It was a regular occurrence that my mum and Smithy would go collecting.

Always Smithy and myself staying in the car.

It was these times that something would happen.

I never told anyone what was happening to me. I never ever attempted to tell anyone, I didn't know what to do.

Between the ages of 12 and 13 years, I'm unsure of exactly how old I was, Smithy penetrated me.

Smithy a part-time job, he cleaned a few banks. I'm unsure of which bank we were in, but it was in the Perth metro area.

I remember I was standing up, Smithy was standing behind me.

Smithy had undid my pants. By this time I did whatever he told me to, I never complained about the acts we were doing. It had happened to me so often that I accepted what was happening.

Smithy had pushed me over an office desk.

I said, "What are you doing?"

He said, "Shut up."

{ Smithy then put his penis inside my bottom. 24

It was only partially inside.

I pulled away, and pushed him off me.

Smithy never tried to do this to me again.

It wasn't long after that Smithy made me and [BMF] [REDACTED] perform sexual acts together.

I was approximately 12 to 13 years old.

[BMF] was about the same age as me, I think he may have been slightly younger.

[BMF] lived with Smithy.

It appeared that [BMF] did whatever Smithy told him too.

I remember one time, we were at the Kewdale Hotel,
there was me, [BMF] and Smithy.

We were in the back of the wagon.

[BMF] has done exactly what Smithy told him.

He put his penis into my bottom. 25.

I tried to get away.

I said, "Stop it hurts, I don't want to."

[BMF] just pushed me down onto my stomach and
continued to penetrate me until he ejaculated inside me.

The whole time Smithy was there, he was watching, and
masturbating himself.

I can remember another occasions, not long afterwards,
the three of us were once more at the car-park of the
Kewdale Hotel.

This time Smithy told me to do it to [BMF]

I then put my penis into [BMF]'s anus. 26.

[BMF] always did what Smithy told him too.

During this Smithy was masturbating himself.

I remember I then had to help him, on his instructions. I
masturbated Smithy until he ejaculated. 27

I never told my mother what was happening for many reasons. Smithy had control over my mother, and especially over me.

I only told my mother in about 1993, what he did to me.

The first person I ever told was my old girlfriend [REDACTED]
[REDACTED]

I told her in 1991.

The reason I have come forward now is because finally I have been able to deal with what has happened to me. I have seen counsellors, and I am now able to discuss what has happened.

I contacted the police because I want the matter to be dealt with properly, I want Smithy to be punished for what he has done.

I declare that this statement is true to the best of my knowledge and belief and that I have made this statement knowing if it is tendered in evidence, I will be guilty of a crime if I have wilfully included in this statement anything which I know to be false or that I do not believe to be true.
