She is up to speed with everything and is going to sit with me as an objective person with the aim to just get said what needs to be said. I think Atma needs to be included in this loop soon i.e send out the drafts to everyone and arranging for a time for them to be discussed. Thoughts please. Regarding re-doing the documents: RC: the links didn't work in the second cover letter so I resubmitted a third which had all the previous mistakes full removed. Somehow the underlining of the errors doesn't come across so well to me and as i have said in the comments on the doc, it may be better to say what we should have done than what was done. >> One big point about this all is that I feel like the shared responsibility for the mistakes should run a bit wider than just you, Surya and Gurubhakta. Really I think that myself, Sadashiva and Kriya should be owning some of this stuff up as we have not guided you guys as much as was needed especially in regards to the RC. Also in the MD issue we could have been more decisive and given more guidance as to appropriate action. >> Now that we have an extension, I would like to discuss the documents a bit further tomorrow. So I would suggest letting Atma know about the extension, but not sending her the redrafts today, but waiting to see what comes out of discussions tomorrow. >> Also what were your thoughts on Sadashiva's comments to re-do the documents the correct way and re-send them out - i.e. **REDACTED** without reference to Munger and the RC one with Swamiji's name completely removed rather than just crossed out? >> OMs > J >>> <00. Then the apology section is all apology. Otherwise it might feel like we are justifying ourselves. It also does read as though Rishi was responsible for a lot of it and that won't come across well (especially given Ratnashakti's wording to me in the extension approval). >>>> Re the RC point - is it an error/omission that you have only referred to YAMM directors in section 3 and not the SYA directors? And YAMM doesn't have directors, they're called something else (officers? OD will know). As I mentioned to you before, I should have insisted that I review the RC submission before it went out and if you want to add something to that effect with my name feel free. >>>> I think both matters probably need tighter wording on the rectification of systems bit so that it's really clear what we mean. I've got to go out now but I'll have another look later. >>>> And both need a proper proof read and grammar check but that can happen by Mukti. >>>> Well done. I keep thinking of
