I've just got off the phone with Glyn Baker, Sex Crimes Manager NSW.

He advises the following:

1. John is at Miranda Police Station with his Mum and Dad.
2. He is refusing to be interviewed.
3. He is in the docks being charged.
4. 4 counts of Aggravated Indecent Assault of a child under 16 by a person in authority. Section 61c of the Crimes Act.
5. Will be given Police bail with strict conditions:
 - a. Hand in Passport
 - b. Not attend 3 locations
 - i. Laguna Street Public School
 - ii. Caringbah Public School
 - iii. St Patricks Primary School Sutherland
 - c. Not contact the current 2 families
 - d. No employment with children
 - e. Internet ban
6. Court date to be set and advised asap.
7. Early next week Police will continue investigating 2 further "children at risk" – no further details can be provided at this time.
8. 2 boys currently. Sex of 2 additional children not known

Glyn has asked me / YMCA to work closely with him on any media, parent or community communications until case is closed.

He is on call at all times and will keep me informed of any further developments over the weekend and beyond.

Investigating officers have been given the weekend off. Resume Monday.
