He said, "Sorry, again. I really don't know, what was the connection. Like I know that you mentioned that Moshe, Moshe Gutnick heard something and that maybe it came from Moshe. I really don't know. I don't even know."

I said, "Do you know roughly"

He said, "It wasn't relevant."

I said, "Sorry"

He said, "It wasn't relevant how he heard you know, the relevance was to have a discussion with me and tell me."

I said, "Did he ask you ever who was affected or?"

He said, "Did he ask me what? Say it again."

I said, "Did he ever know which kids or did he ask you which kids it affected, or did he?"

He said, "I think he, I think he knew, I think he heard about a particular incident and he, he didn't pry into it."

I said, "OK. Because my understanding was that Lesches knew about \_\_\_\_\_ )."

He said, "Correct. I think I mentioned that to either you or \_\_\_\_\_ directly, and Moshe found out as well about \_\_\_\_\_ and told me to keep away from \_\_\_\_\_ and make sure I do not invite him over to my house and that was the end of the discussion."

I said, "But Lesches knew for a while. Lesches knew I think from before you were married. That is my understanding"

He said, "I don't even recall at what point in time, at what stage or what age I was at that time the conversation took place, I really don't remember, I don't have a proper recollection of it."

I said, "Did anyone else know? Did Avremki know or any of these people?"

He said, "Not to my knowledge. I don't know. I really don't know. I never got any comments from any one there. Except, the only two Rabbonim that ever broached the subject, was that on one individual occasion Lesches spoke to me, and on one individual occasion Rabbi Feldman spoke to me, that's it."

I said, "Have they ever spoken to you again about it?"

He said, "No, no, it has never ever come up again. No."
