Dear Eli,

I am only attaching the individual pages from the transcript from my police interview which took place on the day that I was arrested, which relates to any mention of your father & R. Lesches.

The rest of the pages are not at all relevant and my wife prefers that I not send it.

I am also attaching 3 excerpts from my phone conversation with AVB [REDACTED] which he recorded and which was subsequently transcribed and given to my lawyer by the police. Once again I am only including the relevant parts of the conversation that either mention your father or Rabbi Lesches, none of the rest of the conversation relates to your father or any Rabbonim.

To the best of my recollection, I had only one conversation with your father. Your father did not say that he heard such and such. The specifics of what might have been said when we had a chat are very vague at best, as it took place a very long time ago, but to make an educated guess, considering how long ago this conversation took place, he may have said that there was a possible rumor that he heard, and if there was any truth to the rumor, I should do the right thing and conduct myself in a chasidische manner. I certainly did not make any confession in any way shape or form!!! We are not Christians (le'havdil), we do not meet up with the rabbi and confess our sins!!! I did not discuss with your father nor any other rabbi anything ever on any such topic! I am quite certain that if your father knew of anything specific occurring, he would have taken serious action, but it was just a rumor, and nothing more.

There was also a once off conversation with R. Lesches, and the conversation was also very vague, he did not tell me that he heard any specifics, just that if a certain rumor was true, that I should stay away from a certain individual.

If I can be of any further assistance, please let me know.
