Dear Tony,

Following on from our telephone conversation today, I advise as follows:-

I am sending by email item no 2 referred to in the Schedule attached to the Notice to Produce. Items nos 1 and 3 will come by regular mail.

Please note further that as we are a not a direct service provision agency, we have no direct contact with children, nor do we provide activities facilities programs or services that provide the means through which adults have contact with children. (definition of institution section (i))

There is only the possibility that a child may ring in to our telephone referral line. Further, our policies and procedures manual is in the process of being updated pursuant to the change in Victorian legislation. We also advise that we are part of the JCCV child protection reference group and as such have been assisting in their child protection training and have been involved with the affiliates in drawing up policies and procedures for their organisations.

I advise further that following on from our conversation, names have been redacted from the information being sent to you, due to the fact that we represent ourselves as being a confidential and anonymous referral line. As discussed, should you require further information we can provide it.

In relation to the training being sent to you in electronic form, there were different trainings provided by different trainers, so I am sending you what they provided to them. The second group also received some legal overviews provided by me so I sending that as well as it encompasses a section on mandatory reporting.
